C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.


B. ADDITIONAL COMMENTS TO SUPPORT JD:

The Corps assessed the approximately 26 acres of waters in the review area and determined they are isolated and non-jurisdictional. These waters are considered isolated and not adjacent because:


1. There is not an unbroken surface or shallow sub-surface connection to jurisdictional waters. A review of hydrographic and topographic data shows that these waters do not have any apparent direct or indirect surface connections to a downstream TNW. The review area is located within the Lake Wales Ridge. The waters are surrounded by uplands with nonhydric soils and existing topography prevents surface outflows to downstream waters. There are no ditches, swales, or cattle trails that could serve to hydrologically connect the isolated waters to a downstream TNW. A field inspection revealed no surface connections to waters of the U.S. The Southwest Florida Water Management District determined Lake Saint Charles is a closed basin with no outflow to external bodies of water. Available LiDAR, topographic and hydrographic data support this finding.

2. The wetlands are not physically separated from jurisdictional waters by man-made dikes or barriers, natural river berms, beach dunes, and the like.

3. The proximity to the RPW is not reasonably close to support a science-based inference of ecological interconnectedness. The waters are more than 3,000 feet from any aquatic resource that is a potential water of the U.S. connected to a downstream TNW.

 Location Map





Aquatic resources in green





Review area within pink polygon







