This feature is excluded because it is a ditch that is not traditional navigable waters, tributary, and is not constructed in adjacent wetlands. The onsite ditch is a relic of past agricultural ditching within the area. This ditch was severed from downstream flow (through residential development in the early 1980's) and remains an isolated, man-made feature.
