**C. Additional comments to support AJD:** Information submitted with the JD request and obtained from the sources listed above demonstrate that the wetland is physically remote and hydrologically isolated from any (a)(1)-(a)(3) waters. The wetland is surrounded by uplands and artificial barriers that do not allow for any direct surface hydrologic connection with any (a)(1)-(a)(3) waters.
