Tributary to Spring Creek	100	linear feet	(b)(3) Ephemeral feature, including an ephemeral stream, swale, gully, rill, or pool.	This ephemeral tributary does not provide sufficient flow duration to constitute sustained flows during wet or dry seasons. This tributary only exhibits ephemeral flow in direct response to precipitation runoff. A review of multiple years of aerial imagery provided no evidence of an intermittent flow regime. Based on annual rainfall, drainage size and location within the landscape, it is not likely that this ephemeral tributary would receive flows more than in a direct response to precipitation.
