The reach does not exhibit any indicators of persistent and continuous flow; therefore, this ephemeral channel is non-jurisdictional.

**B. Typical year assessment(s):** [The Antecedent Precipitation Tool \(APT\) analysis determines if the date specific observation falls within the normal periodic range for the geographic area based on a rolling thirty-year period. The APT indicated that the period of August 18, 2020, had a “wetter than normal” condition during the dry season, subsequently there were pools of standing water observed, most notably at the upper reach of the ephemeral channel, with stretches of completely dry stream bed. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
