The 42.5 acre wetland is surrounded by residential development to the east and west, to the north by a road, and the south by a non-jurisdictional ditch (outside of the review area) and a road. The ditch is not an (a)(1) water, does not relocate a tributary, was not constructed in a tributary, and was not constructed in an adjacent wetland. Therefore, it is a non-jurisdictional ditch. The wetland is not adjacent to an (a)(1)-(a)(3) water.
