The surface water may contribute intermittent flow to a downstream (a)(2) water, but if so, would do so via upland-cut ditch and extensive system of underground culverts/pipes running through an urbanized landscape constructed within upland soils. Accordingly, the subject surface water is not directly connected via continuous jurisdictional waters to, an (a)(1) through (a)(4) water. The subject surface water also does not lie within the typical year floodplain of an (a)(1) through (a)(4) water.

<sup>5</sup> Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.
