Surface Water 1	0.63	acre(s)	(b)(8) Artificial lake/pond constructed or excavated in upland or a non-jurisdictional water, so long as the artificial lake or pond is not an impoundment of a jurisdictional water that meets (c)(6).	Per review of historic aerials and soils maps, the subject surface water appears constructed in historically wetland area, but the wetland area would not have been jurisdictional under the NWPR, as it is not hydrologically connected to an (a)(1)-(a)(4) water.
Surface Water 2	0.13	acre(s)	(b)(8) Artificial lake/pond constructed or excavated in upland or a non-jurisdictional water, so long as the artificial lake or pond is not an impoundment of a jurisdictional water that meets (c)(6).	Per review of historic aerials and soils maps, the subject surface water appears constructed in historically wetland area, but the wetland area would not have been jurisdictional under the NWPR, as it is not hydrologically connected to an (a)(1)-(a)(4) water.
Surface Water 3	38.50	acre(s)	(b)(1) Lake/pond or impoundment that does not contribute surface water flow directly or indirectly to an (a)(1) water and is not inundated by flooding from an (a)(1)-(a)(3) water in a typical year.	The natural lake/surface water does not contribute intermittent flow to a downstream (a)(1)-(3) water. Historically the lake was connected via several segments of upland-cut ditches and underground culverts/pipes running through an urbanized landscape. Decades of surrounding urban development has severed any potential hydrologic connection to (a)(1)-(a)(4) waters. Accordingly, the subject surface water is not directly connected via continuous jurisdictional waters to an (a)(1)-(a)(4) water. The subject surface water also does not lie within the typical year floodplain of an (a)(1)-(a)(4) water.

⁴ Some excluded waters, such as (b)(2) and (b)(4), may not be specifically identified on the AJD form unless a requestor specifically asks a Corps district to do so. Corps districts may, in case-by-case instances, choose to identify some or all of these waters within the review area.

⁵ Because of the broad nature of the (b)(1) exclusion and in an effort to collect data on specific types of waters that would be covered by the (b)(1) exclusion, four sub-categories of (b)(1) exclusions were administratively created for the purposes of the AJD Form. These four sub-categories are not new exclusions, but are simply administrative distinctions and remain (b)(1) exclusions as defined by the NWPR.

Wetland 1	5.63 acre(s)	(b)(1) Non-adjacent wetland.	Wetland is adjacent to Surface Water 3 (described above). Surface Water 3 is non-jurisdictional, therefore, Wetland 1 is non-jurisdictional as the subject waters are not directly connected via continuous jurisdictional waters to an (a)(1)-(a)(4) water. The subject wetland also does not lie within the typical year floodplain of an (a)(1)-(a)(4) water.
