The Senate added another \$200 million in school operating aid for schools beyond Spitzer's plan, giving more generous aid hikes to 220 of the 303 districts the governor wanted held to 3 percent increases. Some suburban districts would become big winners; Amherst, for instance, would see its hike in operating aid increase from 3 percent to nearly 25 percent under the Senate plan while Williamsville would go up 18 percent.

Buffalo, too, would see more aid under the Senate plan, but critics of the Senate plan cautioned that unless the current, Byzantine aid formula is

smaller shares to the suburbs will only convince more people to flee the state.

"Directing extraordinary levels of funding to a handful of wealthy school districts is not an option," Assembly Speaker Sheldon Silver, D-Manhattan, said last week.

Assemblyman James Hayes, a Republican who represents big suburban districts like Amherst and Williamsville, said, "My concern is if we don't continue to get more state aid and don't continue to send massive property tax relief for homeowners, we risk undermining support for public education by taxpayers."

### Proposed Plan for the Tonawanda Landfill Vicinity Property Released for Public Comment

Formerly Utilized Sites Remedial Action Program  
(FUSRAP)

The Proposed Plan for the Tonawanda Landfill Vicinity Property explains the U.S. Army Corps of Engineers' (USACE) recommendation for the properties. The Corps has established a 90-day comment period for this document. During this 90-day period, the local community will be able to review and comment on the Proposed Plan before the Corps makes its final decision for the site. The Corps will document its decision in the final report that will close out the site - the Record of Decision. To facilitate the collection of public comment, the Corps will have a public meeting on April 25, 2007 (see below). The official 90-day comment period for the Tonawanda Landfill & Vicinity Property Proposed Plan closes on June 26, 2007.
