Summarize overall biological, chemical and physical functions being performed: The reservoir is providing water attenuation and water quality functions. It does not contain consistent emergent vegetation, which limits habitat support to fish and wildlife. The vegetated buffer surrounding the surface water is providing limited support and habitat structure, and water quality benefits. The pond has no hydrologic connectivity to a TNW or non-TNW.

C. SIGNIFICANT NEXUS DETERMINATION

A significant nexus analysis will assess the flow characteristics and functions of the tributary itself and the functions performed by any wetlands adjacent to the tributary to determine if they significantly affect the chemical, physical, and biological integrity of a TNW. For each of the following situations, a significant nexus exists if the tributary, in combination with all of its adjacent wetlands, has more than a speculative or insubstantial effect on the chemical, physical and/or biological integrity of a TNW. Considerations when evaluating significant nexus include, but are not limited to the volume, duration, and frequency of the flow of water in the tributary and its proximity to a TNW, and the functions performed by the tributary and all its adjacent wetlands. It is not appropriate to determine significant nexus based solely on any specific threshold of distance (e.g. between a tributary and its adjacent wetland or between a tributary and the TNW). Similarly, the fact an adjacent wetland lies within or outside of a floodplain is not solely determinative of significant nexus.

Other: (explain, if not covered above): **All irrigation ditches (0.59 ac total) and the artificial reservoir (0.90 ac) are man-made and upland-cut, and do not drain any wetlands. Isolated reservoir wetland (0.90 ac) and old irrigation ditches are not neighboring or adjacent to nearest jurisdictional water body (Mud Lake/Boggy Creek), being greater than 300 feet from the ordinary high water mark and 100-year floodplain of the latter. Isolated reservoir wetland (0.90 ac) is separated from the Mud Lake/Boggy Creek system and floodplain by upland pine flatwood and hardwood forest communities, and existing RIBS. Existing upland-cut ditches (0.59 acre) adjacent to the isolated wetland/reservoir are consistently dry or have no ephemeral flow, even when other on-site ditches are wet.**




